

WebJA Privacy Policy

How We Collect and Use Information

We ask for certain information in order to improve the user experience WebJA.

We collect the following types of information about you:

Information you provide us directly:

You may browse our website anonymously, however to use certain features, you are required to create an account. Upon account creation, we only request that you provide an email address which is used to identify you on the website and will be used by us to communicate with you.

In order to publish listings (advertisements) on the website, we require more information in an effort to ensure that listings posted on our website are for genuine services/products. Information collected at this phase include a company name (if provided), legal first name and last name, personal cell phone number, a contact address and phone numbers as well as a contact email address; all of which, excluding the email address that the account was created with along with the personal phone number, will be visible to the public if provided. This is done in order to provide users with a means to contact the individual who published a listing.

Information we may receive from third parties:

We may receive information about you from third parties. For example, if you access our websites or service through a third-party connection or log-in, for example via Facebook log-in, Google log-in, Disqus (blog comment service used on our website). These third parties may pass certain information to us including but not limited to, the user ID and the email address associated with that account, an access token necessary to access that service, any information that you have permitted the third party to share with us, and any information you have made public in connection with that service. If you allow us access to your friends list, your friends' user IDs, and your connection to those friends, may be used and stored to make your experience more social, and to allow you to invite your friends to use our service. You should always review, and if necessary, adjust your privacy settings on third-party websites and services before linking or connecting them to outside services (ex: WebJA).

Analytics information:

We may directly collect analytics data, or use third-party analytics tools and services, to help us measure traffic and usage trends for the service. These tools collect information sent by your browser or mobile device, including the pages you visit and other information that assists us in improving the service. We collect and use this analytics information in aggregate form such that it cannot reasonably be manipulated to identify any particular individual user.

Cookies information:

When you use our service, we may send one or more cookies — a small text file containing a string of alphanumeric characters — to your computer that uniquely identifies your browser. We use cookies for functions such as keeping you logged in to a particular browser so you don't have to re-enter credentials each time you visit – if you choose to use this feature, and also in conjunction with our analytics tools. A persistent cookie remains on your hard drive after you close your browser. Persistent cookies may be used by your browser on subsequent visits to the site. Persistent cookies can be removed by following your web browser's directions. A session cookie is temporary and disappears after you close your browser. You can reset your web browser to refuse all cookies or to indicate when a cookie is being sent. However, some features of the service may not function properly if the ability to accept cookies is disabled.

Commercial and marketing communications:

We use the information we collect or receive, such as your email address, to communicate directly with you. We may send you emails containing newsletters, promotions, and special offers. If you do not want to receive such email messages, you will be given the option to opt out or change your preferences. We also use your information to send you Service-related emails (e.g., account verification, changes/updates to features of the Service, technical and security notices). You may not opt out of Service-related emails.

Sharing of Your Information

We will not rent or sell your information to third parties outside WebJA without your consent, except as noted below:

- Who we may share your information with: We may share your information with third-party business partners. Third party business partners will be given limited access to your information as is reasonably necessary to deliver the service, and we will require that such third parties comply with this Privacy Policy, or operate under a similar privacy policy.
- Who can see User Content: Any User Content that you voluntarily disclose for posting to the Service becomes available to the public.
- Who can see your email address: The email address you use to create your account will not be visible to the public and is used to identify you on our website and also used for service-related operations (such as account verification, password reset, important changes to our services).

Instances where we are required to share your information:

WebJA will disclose your information where required to do so by law or subpoena or if we reasonably believe that such action is necessary to (a) comply with the law and the reasonable requests of law enforcement; (b) to enforce our Terms of Use or to protect the security, quality or integrity of our Service; and/or (c) to exercise or protect the rights, property, or personal safety of WebJA, our users, or others.

What happens in the event of a change of control?

In the event that the ownership of WebJA is changed, users of our services will be notified of any change to this policy prior to those changes becoming effective and until those changes become effective, the latest version of this policy will remain in effect. Users may choose at that to continue/discontinue their use of our service and if they so desire, delete their account, which will lead to any information shared with us directly being deleted.

Third-Party Services on WebJA

We may also share certain information such as your location, browser, and cookie data and other data relating to your use of our service with third-party services. Third-party services used by WebJA include Google's Firebase (<https://firebase.google.com/>) for storing your account credentials and photos that are upload via WebJA, Google Analytics (<https://www.google.com/analytics/>) for tracking traffic on our website and analyzing demographics, Google AdSense (<https://www.google.com/adsense>) for serving ads and Disqus (<https://disqus.com/>) for handling comments for listings posted on WebJA. These services require us to share information such as your location, browser, and cookie data. For more details about how they store and secure data collected please review their respective policies.

Links to other Websites and Services

Although WebJA seeks to and tries to ensure that links to external services are such that will not cause harm to any of our users, we are not responsible for whatever harm/damage is caused by visiting an external website through links that may be posted by users of our service. We advise caution when visiting links that may take you outside our website.

Changes

We reserve the right to alter and/replace these changes as we see fit. Upon a revision to our Terms, we will notify the users prior to the new terms becoming effective.
